4. Discussion of and action on the minutes of the Special Meeting of the Planning and Zoning Commission dated March 8, 2022. (Approval Item; Staff)

Motion was made by Commissioner Hozza, second by Commissioner Wade, to approve the minutes as submitted.

Planning and Zoning Commission April 5, 2022 Regular Meeting Minutes

5. Discussion of and action on a request by B.R. Anderson for approval of a variance pursuant to Municipal Code of Ordinances Chapter 98 Zoning, Section 98-72 Old Town Helotes Special District, subparagraph (g)(7) Creative Sign Review authorizing the use of a v-shaped freestanding sign for B-Daddy's BBQ located at 14436 Old Bandera Road #3, Helotes, Texas 78023, more particularly described as BCAD Prop. ID No. 242097. (Recommendation Item; Applicant)

Speaking on this item was B.R. Anderson, restaurant owner of B-Daddy's BBQ. The current monument sign on Bandera Road (S.H. 16) is not visible due to 1.) the way Bandera Road curves and 2.) a lot of oak trees. The variance request is to allow a 10' tall v-shaped freestanding sign with two 4'x8' sign panels that will provide visibility of the restaurant to both northbound and southbound traffic lanes on Bandera Road. Each sign panel will have the restaurant logo. The location of the proposed sign is behind the existing 6' tall cedar post fence (sign poles will be hidden by fence). Mr. Anderson noted the current monument sign would be abandoned.

Discussion included B-Daddy's BBQ is located in the Old Town Helotes Special District (OTHSD). Sign regulations in the OTHSD do not identify v-shaped freestanding signage as an authorized sign classification, therefore, the applicant submitted a variance request. Per Code, no variance shall be granted in the OTHSD except through a Creative Sign Review. The Commission understood the need for visibility, however, believed the v-shaped freestanding sign, as presented, did not meet the criteria or intent of the Creative Sign Program.

- \*\*Motion made by Commissioner Blue, second by Commissioner Cato, to disapprove the item as presented. Motion to disapprove carried unanimously.
- \*\*Note This is a recommending motion to the City Council. Per Code, the variance through the Creative Sign Program shall be subject to review by the P&Z Commission and approved by the City Council.
