Helotes Municipal Court to Conduct Warrant Resolution Initiative

Helotes Municipal Court Administrator announced today that the Helotes Municipal Court is conducting a Warrant Resolution Initiative beginning March 1st through March 31st, 2025. Those individuals with active warrants, deriving from Class C offenses such as traffic violations or other Class C misdemeanors, should immediately contact the Helotes Municipal Court to resolve their cases.

The City of Helotes Municipal Court is offering a 25% discount on warrants if paid in full by March 31, 2025. The discount will only be applied if paid in person, by mail or online (3% processing fee will be applied) with the Helotes Municipal Court (YOU MUST CALL TO VERIFY THE DISCOUNT AND AMOUNT TO PAY ONLINE). The Helotes Municipal Court is encouraging defendants to take advantage of the options available to resolve outstanding warrants. The discount will not be offered after the Warrant Resolution Initiative has ended.
