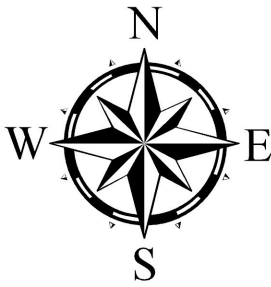


CITY OF HELOTES
